## I

## To Promote Research Interaction and Co-Operation.

This memorandum of understanding entered into on between R. M. G. ARTS \& SCIENCE COLLEGE, NAGBHID (hereafter referred to as RMGC) run by Manoharbhai Shikshan Prasarak Mandal, Armori, Dist. Gadchiroli through Principal - A College run by Public Trust. 8

And
NAGPUR VETERINARY COLLEGE, SEMINARY HILLS, NAGPUR-440006(hereafter referred to as NVC) undertaking teaching, research and extension activities under Maharashtra Animal \& Fishery Sciences University, Telangkhedi, Nagpur through the Associate Dean.

## 1. Objectives.

RMGC and NVC desiring to promote research co-operation between the two institutions and will undertake joint research work in the areas of mutual interest.

The concerned teachers, PG Scholars, PhD. Scholars, Scientist and technical personals of RMGC and NVC will formulate (a) research projects for joint work with due approval of both the institutions and (b) training programmes for staff, technical personnel within the areas of co-operation will be undertaken at the two institutions.

Joint sponsored and consultancy projects with both long terms and short term goal could be undertaken, keeping in view the interest and philosophies of the respective institutions.

## 2. Exchange/Deputation of staff.

Both RMGC and NVC jointly agree, toexchange PG Scholars, Ph.D. Scholars, Scientist and technical personals on full time/part basis for a limited period not exceeding than one year at a time for the purpose of implementation of joint tasks within the areas of co-operation. The expenses towards research on honorarium, consumables, travel and contingencies shall be spent by each party on their own as specified in the joint research programme.

The PG Scholars, Ph.D. Scholars, Scientist/technical personnel will be encouraged to deliver lectures/invited talks at the other institutes, The TA/DA and the honorarium for the lectures shall be borne by the host institutions.

## 3. Joint Conference/Workshop/Course/Dissertation

Both the institutions agree to hold/conduct whenever feasible, joint workshop, conference, training courses within the areas of co-operation.

## 4. Sharing of Facilities

The two institutes agree to shape their respective important R \& D facilities in order to promote academic and research in the area of co-operation to intensify the high priority programme of science and technology.

The two institutes agree to exchange software, other material and components developed in house in the areas of co-operation (if advisable) within the framed rules governing the two institutes and maintain secrecy and confidentiality.

Access to laboratory, Library and other supporting facility for the staff involved in the joint research programme at a RMGC and NVC will be provided by both institutes.

## 5. Areas of Co -operation

The areas of co-operation will be defined and modified from time to time by the co-operation committee set up for the purpose. The areas identified for cooperation are:
a) NVC research scientist and RMGC team shall work on standardizing Ayurveda research.
b) Evaluation of existing and new herbal medicines/herbs/formulae will be done to generate scientific evidence.
c) Identifying areas and strategies for collaborative integration of basic research and herbal formulation in the management of diseases.
d) Availing Animal House facilities of NVC, under the proposed project.

## 6. Co-ordination Committee

The following will constitute the coordination committee to monitor and review the collaboration programme between two institutes:
a) Principal, RMGC and/ or his nominee (S)
b) Associate Dean, NVC and/ or his nominee (S)
c) Coordinator, NVC
d) Coordinator, RMGC
e) HOD of the concerned Department(s) from both of the institutions to be invited as and when needed.

## The Co-ordination Committee shall

- Review the progress of the identified programmes at least once a year.
- Consider the new R \& D proposals for joint collaboration and implementationon case to case basis including intellectual property right (IPR) and financial arrangement.
- Consider the addition/deletion of co-operation between the two institutes during review.
- Consider the continuance of the MOU,


## 7. Publication and Patents

All publications in the programmes of co-operation will be co-authored by the concerned staff /research fellow and technical personnels of RMGC and NVC. The coordination committeeshall review the patentability aspect of the research work and direct whether a patentpublication be made.

RMGC and NVC will be joint holders of the Intellectual Property Right (IPR)/ Patents out of joint work. The decisions on ownership, licensing, cost, royalties, etc. shall be and made by coordination committee recommendation project/activity specific agreement that will be followed in MOU.

## 8. Disputes -

Any dispute arising out of this MOU will be settled by mutual negotiations between the two parties. In case of any dispute relating to interpretation of clauses of this MOU, the case shall be referred to the Arbitrator appointed by NVC, Nagpur only. The word passed by such Arbitrator shall be binding on both the parties as per the provisions of Arbitration Act 1996.

## 9. Non Disclosure

In case of joint research and consultancy projects taken up by RMGC and NVC, no party shall disclose any information to media/ any unauthorized person from each institute in any form whether electronic/print without mutual consent and approval by coordination committee.

## 10. Validity Period

This MOU shall remain valid for a period of five years from the date of signing unless renewed at the end of validity period of MOU, a fresh MOU with similar/modified terms may be considered for signing.
