- I shall ensure to adhere with all the relevant and applicable laws, to the best of my knowledge and ability.

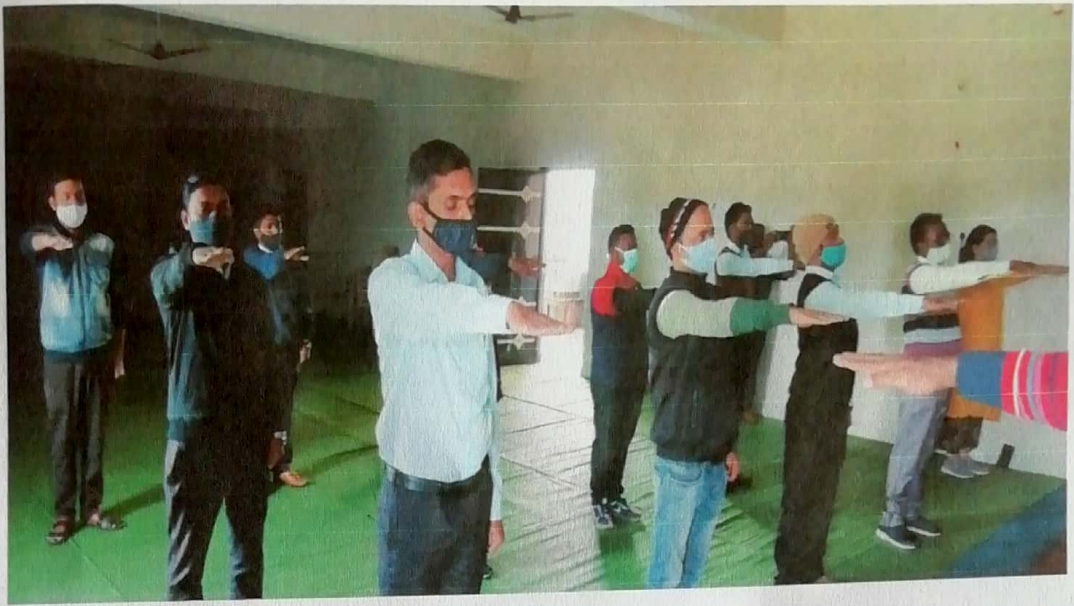
